

This Fact Sheet will help guide you with GST.

Good & Services Tax (GST)

Should I include GST in my budget?

This will depend if your organisation is registered for GST or not. If you are unsure of your GST status, you can search for your organisation on the ATO webpage www.abr.business.gov.au

If you are registered for GST, then the budget provided in your application should be exclusive of GST.

If you are not registered for GST, then the budget provided in your application should be inclusive of GST.

If you are registered for GST

If you are registered for GST, you should not include GST in your budget expenses. Where applicable, DELWP will pay the grant amount plus GST. The budget provided in your application should be exclusive of GST.

For example, if Contractors have quoted \$11,000 including GST, then you will request only \$10,000.

If you are not registered for GST

If you are not registered for GST, please ensure that the budget provided in your application covers the total cost of your expenses including GST where applicable (e.g. include the impact of any GST on your purchases).

Ensure that the budget in your application covers your total costs so you are not out of pocket. Therefore, the budget provided in your application should be inclusive of GST.

For example, if Contractors have quoted \$11,000 including GST, then request the full \$11,000.
