### Biodiversity 2037 Activity data requirements v1.0

Many Victorians contribute to biodiversity protection and enhancement. To account for these contributions and measure progress against Biodiversity 2037 these activities are mapped along with key activity information. The Biodiversity 2037 activity data tables contain the fields and values important for understanding activities delivered for biodiversity benefit. The activity data tables cover project and activity management information; who is involved in delivery; activity delivery details such as standards of delivery, timing and frequency.

## Attribute description

The following are descriptions of the fields (attributes) that apply to all or most of the Activity tables.

Attribute	Description
Reporting standard name and version	The name of the data standard being used for the data supplied. This reporting standard is Bio2037 V1 May2020. DELWP Output data standard version might also be used
Year activity delivered	The financial year the activity was delivered. Note: when using the shapefile template 2019 – 2020 should be recorded as 1920. Activities delivered at the same locations in multiple years should be reported separately each year.
Fund source	The name or identifier of the program funding delivery. This should be supplied by the funder.
Project ID:	The name or identifier, usually a code, that identifies the project under which activities are delivered. This code is often supplied by the funder.
Delivery agent	The main organisation responsible for delivering the activity. This may or may not be the same organisation doing the on-ground works.
Delivery agent name	The name of the organisation responsible for delivering the activity
Planned management outcome	The outcome the activity contributes to as described in government policy, plan or strategy.
Environment	The environment in which the activity is being delivered
Title	The activity title is provided in each table. For Animal control one title should be selected.
On ground works agent (Agent doing the work/delivery)	The persons or organisation doing the on-ground works. This may or may not be the same as the Delivery agent.
On ground works agent name	The name of the organisation doing the on-ground works. This should not be supplied for private individuals or companies
Total volunteer number	The total number of volunteers involved in delivering an activity for the reporting period. Where volunteers are involved in delivering a range of activities the total number of volunteers can either be reported against the main activity or split across the range of activities.
Total volunteer hours	The total number of hours that volunteers contribute to delivering an activity for the reporting period. Where volunteers are involved in delivering a range of activities the total number of hours can either be reported against the main activity or split across the range of activities.
Purpose	The specific purpose of the activity. This will usually align with the planned management outcome. Example: Planned management outcome is Species control, the Purpose could be Protect Agriculture, Fire protection or Protect water etc.
Species	The species being managed/protected. This field applies the Victorian Biodiversity Atlas (VBA) taxon ID. Please refer to the <a href="#">VBA_Species_Checklist_date</a> .
