Site Assessor will discuss your options for generating a native vegetation credit with you, assess your property, draft a security agreement and management plan with you, and liaise with the Department of Environment, Land, Water and Planning to secure the on-title agreement and the native vegetation credit applications.

Credit Broker will assist to facilitate a search to locate suitable native vegetation credits, facilitate negotiations, draft a credit agreement and process with the native vegetation credit register. A Credit Broker can conduct “Over the counter” trades which is a mechanism to facilitate quick trades for General Biodiversity Equivalent Units where the offset has been determined and purchasing is streamlined. Note: this services is not available for Specific Biodiversity Equivalent Units.
