## Dargo Galaxias (*Galaxias mungadhan*)

Taxon ID: 528523

Action statements are developed under the *Flora and Fauna Guarantee Act 1988* (FFG Act). Their preparation and implementation complement the FFG Act strategy *Protecting Victoria's Environment – Biodiversity 2037* and its vision that “Victoria’s biodiversity is healthy, valued and actively cared for”.

### Conservation Status

#### Critically Endangered

**Listing criteria:** 3.1.1; 3.1.2(a),(b)(i,ii,iii,iv,v) of the Flora and Fauna Guarantee Regulations 2020.

This means that:

- The Dargo Galaxias has undergone, is suspected to have undergone, or is likely to undergo in the immediate future, a very severe reduction in population size.
- Its geographic distribution is extremely restricted; and
- it is restricted to a limited number of areas that are subject to the same threat or suite of threats that can impact all individuals present; and
- there is a continuing decline or reduction in:
  - its extent of occurrence; and
  - its area of occupancy; and
  - the area, extent, or quality of habitat; and
  - the number of locations or subpopulations; and
  - the number of mature individuals.

## Threats

Threats listed below have been identified through expert consultation, published literature and spatial analysis.

Threat	Description
<b>Introduced species</b>	
Introduced fish	<ul style="list-style-type: none"> <li>Introduced fish can degrade habitat, impact water quality, disrupt ecosystem function, and/or impact directly on individuals through predation, and competition for resources, with potential to lead to loss or fragmentation of populations.</li> <li>Predation by, and to a lesser extent competition with, introduced trout is a major threat to Dargo Galaxias. Incursion of introduced trout into the habitat of the species has been known to cause the reduction in distribution and abundance of Dargo Galaxias. Further incursions could lead to rapid and severe Dargo Galaxias population decline and local extinctions.</li> </ul>
Introduced herbivores	<ul style="list-style-type: none"> <li>Introduced herbivores including deer species (Sambar Deer (<i>Cervus unicolor</i>) and Fallow Deer (<i>Dama dama</i>)), feral horses (<i>Equus caballus</i>) and feral pigs (<i>Sus scrofa</i>) can degrade water quality and habitat through trampling, pugging of wet soils, increasing nutrient loads and erosion of waterway edges.</li> </ul>
<b>Fire</b>	
Altered fire regimes	<ul style="list-style-type: none"> <li>Frequent or intense fire and resultant loss of vegetation in the catchment and riparian zone can increase sediment inflows which can smother fish, eliminate instream habitat such as pools and gaps between rocks, and impact macroinvertebrate food availability and change water chemistry and temperature, degrading habitat and leading to mortality. Post-fire debris flows may also create new barriers to movement.</li> <li>A hotter, drier climate may increase the likelihood or frequency of fire impacting habitat, with the potential to reduce habitat extent and/or condition.</li> <li>As a result of the small, fragmented distribution of the Dargo Galaxias, extreme bushfire events and subsequent sedimentation inputs to habitat could lead to loss of populations.</li> </ul>
Emergency response	<ul style="list-style-type: none"> <li>Some emergency response activities (e.g., vegetation clearance and/or earthworks) can inadvertently lead to alterations in habitat, vegetation structure, flows or erosion, and mortality of individuals.</li> <li>Fire retardant can release chemicals into Dargo Galaxias habitat which can be toxic to the species.</li> </ul>
Fire management activities	<ul style="list-style-type: none"> <li>Fire management operations such as creation of fuel breaks (soil disturbance, slashing) may remove habitat and cause mortality of individuals.</li> <li>Dargo Galaxias is vulnerable to sediment inputs from roads or tracks and mechanical disturbance from heavy machinery.</li> </ul>

Threat	Description
<b>Climate Change</b>	
Altered rainfall and temperature regimes	<ul style="list-style-type: none"> <li>Reduced annual rainfall and increased maximum temperatures will reduce the availability of groundwater outflow and therefore surface water flow, refuge habitat, and affect spawning cues.</li> </ul>
Extreme weather events	<ul style="list-style-type: none"> <li>Climate change may increase the frequency and intensity of storms and flooding, increasing erosion and sedimentation, impacting flow regimes and habitat condition, and potentially causing mortality events.</li> <li>An increased frequency and intensity of flooding could drown out instream barriers, potentially facilitating introduced fish incursion.</li> </ul>
Increased frequency and/or length of droughts	<ul style="list-style-type: none"> <li>Drying and warming of the environment, including droughts, will impact on flow regimes which may lead to a reduction in habitat, and impact recruitment and/or mortality rates.</li> </ul>
<b>Habitat loss, degradation or modification</b>	
Degradation of riparian and/or wetland vegetation	<ul style="list-style-type: none"> <li>Degradation of vegetation in riparian and wetland habitats reduces habitat extent and/or condition, potentially impacting species persistence.</li> <li>Removal of riparian vegetation can alter water temperatures, contribute to soil erosion, stream bank damage and siltation of streams, causing damage to Dargo Galaxias habitat and potentially reducing food availability, refuge, and spawning habitat.</li> <li>As a result of the small, fragmented distribution of the Dargo Galaxias, local habitat modifications and degradation could threaten populations.</li> </ul>
Forestry operations	<ul style="list-style-type: none"> <li>Timber harvesting operations in native forest can contribute to erosion, and sedimentation in the species habitat, which may cause mortality of individuals.</li> <li>Timber harvesting operations in native forest within the species' catchment can alter hydrological regimes causing habitat degradation or loss.</li> </ul>
Livestock	<ul style="list-style-type: none"> <li>Livestock can cause habitat degradation through the combined effects of herbivory, trampling, soil compaction, soil erosion, pugging of wet areas, and excess nutrient loads. This is a particular issue where cattle graze within or adjacent to habitat in catchments where Dargo Galaxias occurs.</li> </ul>
<b>Human disturbance</b>	
Recreational activities	<ul style="list-style-type: none"> <li>Recreational activities such as four-wheel driving, hiking and camping can facilitate widening and extension of tracks and trails increasing the risk of sediment input, access to habitat, and introductions of predatory introduced fish. Collectively these risks can impact recruitment and increase the risk of mortality of the Dargo Galaxias.</li> </ul>
Recreational fisheries	<ul style="list-style-type: none"> <li>Illegal translocation/stocking of introduced trout into Dargo Galaxias habitat has the potential to cause localised extinctions.</li> </ul>
Road and track construction or maintenance	<ul style="list-style-type: none"> <li>Construction and maintenance of waterway crossings, roads and tracks expose the Dargo Galaxias and habitat to disturbance from run-off, soil erosion, siltation, off-target impacts of herbicide use and weed and pathogen introduction, in the immediate area and downstream.</li> </ul>

Threat	Description
	<ul style="list-style-type: none"> <li>Construction of new roads and tracks that provide access into previously remote streams can increase the risk of illegal stocking of introduced trout into habitat.</li> </ul>
<b>Population dynamics</b>	
Loss of genetic diversity	<ul style="list-style-type: none"> <li>Small, greatly reduced, and/or isolated populations are at increased risk of loss of genetic diversity, which leads to a heightened risk of reduced recruitment and/or increased mortality rates.</li> <li>Genetic diversity within Dargo Galaxias populations is low and gene flow is highly constrained between all extant populations, causing inbreeding and potential loss of fitness, adaptability and resilience.</li> </ul>
Population fragmentation	<ul style="list-style-type: none"> <li>Fragmentation of once connected populations into smaller, isolated populations increases the risk of genetic decline and associated changes to recruitment and/or mortality rates.</li> </ul>
Small population size	<ul style="list-style-type: none"> <li>Small populations have lower resilience to the risk of stochastic events, and increased risk of genetic decline.</li> </ul>
<b>Pathogens and disease</b>	
Disease	<ul style="list-style-type: none"> <li>Threatened species with small populations and/or reduced genetic diversity are more susceptible to disease risk, both from known, and new/emerging diseases.</li> <li>Metacercarial cysts, the second life stage of parasitic flatworms (flukes), have been reported in the skin and fins of galaxiids. The prevalence of metacercarial cysts in the Dargo Galaxias population is unknown and requires further investigation.</li> </ul>
<b>Pollutants and toxicants</b>	
Pesticide use	<ul style="list-style-type: none"> <li>Spray drift or off-target damage from pesticide application within or immediately adjacent to habitat for Dargo Galaxias may lead to loss of or damage to habitat and impacts to populations.</li> </ul>
Pollution from terrestrial sources	<ul style="list-style-type: none"> <li>Alpine resort treated sewage is discharged into Precipice creek, a stream that flows into Dargo Galaxias habitat. Whilst this does not present a threat, should untreated sewage inputs occur, they will impact the Dargo Galaxias through impacts on health, recruitment and/or mortality, or indirectly by affecting food availability and/or habitat condition.</li> </ul>

## Conservation Objectives

Conservation objectives are informed by the conservation status and criteria under which the species was listed under the FFG Act. This provides a framework to understand how we can work towards recovery and improve the species' conservation status over time as per the objectives of the FFG Act.

The key objectives of this action statement are:

- Mitigate threats to populations and habitat to increase resilience, improve genetic fitness and minimise future population decline.
- Establish at least three new viable populations within its historic range in the catchments of the upper Dargo River system, preferably in larger/wider streams or over longer stream reaches.

- Increase knowledge of biology, ecology, distribution, demography, emerging threats, and conservation requirements.
- Support community participation and improve awareness of the Dargo Galaxias and conservation of its habitat.

## Conservation Actions

The actions below have been identified through expert consultation, published literature and spatial analysis. Actions are listed in alphabetical order to allow all interested parties to prioritise based on their context, capacity, and capability. Landscape scale actions may mitigate threats for other species. Action	Description
Apply decision support tools for population management	<ul style="list-style-type: none"> <li>• Apply relevant decision support tools (e.g., Population Viability Analysis, Specific Needs Assessment) to inform population and threat management decisions.</li> </ul>
Avoid and/or mitigate impacts associated with fire management	<ul style="list-style-type: none"> <li>• Ensure that Dargo Galaxias distribution data and ecological information is available and considered in fire management activities.</li> <li>• Undertake biodiversity values check prior to fuel management in areas of the Dargo Galaxias habitat, to confirm treatment suitability and timing.</li> </ul>
Community engagement and awareness	<ul style="list-style-type: none"> <li>• Continue to raise land manager and broader community awareness of the importance of protecting habitat and managing threats.</li> <li>• Work with key stakeholders to reduce threats and encourage adherence to behaviours that support a healthy environment.</li> <li>• Increase landholder awareness of the Dargo Galaxias and the impacts of livestock grazing. Provide guidance on the changes to grazing that may be required, such as exclusion of stock from riparian areas, to support the recovery of the Dargo Galaxias.</li> <li>• Continue to identify, promote and support opportunities for community involvement in conservation efforts.</li> </ul>
Compliance and enforcement	<ul style="list-style-type: none"> <li>• Undertake risk-based compliance and enforcement activities to limit the impacts of illegal translocation/stocking of introduced fish and off-road vehicle use on Dargo Galaxias.</li> <li>• Undertake compliance and enforcement of seasonal road closures to minimise risk of erosion and sediment input into Dargo Galaxias habitat.</li> </ul>
Conservation management planning	<ul style="list-style-type: none"> <li>• Review and update, or develop, relevant plans or planning tools to support conservation management of Dargo Galaxias.</li> </ul>
Control introduced fish	<ul style="list-style-type: none"> <li>• Implement and maintain effective management and control of introduced predatory fish in priority areas. Prevent any further releases of introduced trout into catchments where Dargo Galaxias currently occur, and where reintroductions are prioritised.</li> </ul>
Control introduced herbivores *	<ul style="list-style-type: none"> <li>• Implement and maintain effective control of introduced herbivores, including deer, feral pigs and feral horses, in priority areas.</li> </ul>
Develop, update and apply forestry protections	<ul style="list-style-type: none"> <li>• Where relevant, incorporate species-specific protection measures into plans and permits relating to timber harvesting operations in native forest on private land.</li> </ul>

Action	Description
Establish and maintain fencing	<ul style="list-style-type: none"> <li>Where required, establish and maintain fencing to prevent access and damage to habitat from introduced species such as deer, feral horses and feral pigs.</li> </ul>
Ex-situ management	<ul style="list-style-type: none"> <li>Establish and maintain ex-situ populations in suitable secure sites, to service the conservation objectives of the Dargo Galaxias, if required.</li> </ul>
Genetic rescue	<ul style="list-style-type: none"> <li>Investigate the need and options for managing risks from stochastic events and improving resilience through enhancing genetic exchange, via physically linking populations, translocation, or genetic management in an ex-situ setting.</li> </ul>
Improve habitat connectivity	<ul style="list-style-type: none"> <li>Restore habitat and/or provide appropriate engineering solutions to improve connectivity between habitat patches where feasible.</li> </ul>
Manage barriers to movement	<ul style="list-style-type: none"> <li>Maintain or reinforce existing instream barriers (natural or artificial) and construct new instream barriers, where appropriate, to prevent incursion of introduced fish predators.</li> <li>Undertake routine inspection and maintenance of barrier integrity to ensure continued effectiveness.</li> <li>Consider the Dargo Galaxias needs and distribution in decision making around the establishment of new potential barriers to movement.</li> </ul>
Manage impacts from natural disaster events	<ul style="list-style-type: none"> <li>Identify and implement recovery actions for vulnerable populations impacted by natural disaster events (e.g., significant wildfire or flood events). This may include reconnaissance of priority sites, emergency extractions, translocations, ex-situ management, and the return of fish once conditions improved.</li> </ul>
Manage public access	<ul style="list-style-type: none"> <li>Manage access to key habitat for Dargo Galaxias, including seasonal road closures, to limit the risks of disturbance (e.g., from recreational activities).</li> </ul>
Manage road and track works	<ul style="list-style-type: none"> <li>Ensure distribution data are considered in planning road and track works.</li> <li>Protect habitat from disturbances caused by road, track, bridge and ford construction and maintenance.</li> <li>Investigate and mitigate sources of sediment from roads and tracks into streams (e.g., Dargo High Plains Road).</li> </ul>
Protect key habitat	<ul style="list-style-type: none"> <li>Identify and protect habitat areas that provide important refugia from disturbance events (e.g., fire) or significant weather events (e.g., drought).</li> <li>Minimise alterations to groundwater and surface water hydrological regimes upstream of habitat or in surrounding landscapes.</li> <li>Maintain vegetation cover and health along the banks and riparian zone of streams within catchments where Dargo Galaxias occurs.</li> </ul>
Research	<ul style="list-style-type: none"> <li>Investigate barriers to translocation success to inform management.</li> <li>Investigate ecological and life history traits of the Dargo Galaxias.</li> <li>Investigate population genetic structure, levels of genetic diversity and minimum viable population size for successful self-sustaining subpopulations.</li> <li>Investigate techniques for captive maintenance, breeding, on-growing, ex-situ genetic mixing and translocation.</li> <li>Investigate development of a genetic survey probe for galaxiids to improve efficacy of eDNA sampling.</li> </ul>

Action	Description
	<ul style="list-style-type: none"> <li>Identify drought refuges and options to enhance the resilience of current habitat or support the provision of new habitat that would be suitable for the species under climate change scenarios.</li> <li>Investigate the susceptibility of endemic diseases on Dargo Galaxias.</li> </ul>
Restoration and/or revegetation *	<ul style="list-style-type: none"> <li>Undertake restoration and/or revegetation to increase habitat suitability and/or create new habitat areas.</li> <li>Restore vegetated buffers along the stream drainage network (wet or dry, stream channel to headwater drainage lines), within catchments where the Dargo Galaxias occurs.</li> </ul>
Survey and monitoring	<ul style="list-style-type: none"> <li>Undertake targeted field surveys to confirm the extent of all known populations and seek to discover previously undetected populations based on predicted habitat and ecological information.</li> <li>Monitor populations at known sites and other suitable locations to assess distribution, population trends, habitat condition, and the impact of threats to inform management interventions.</li> <li>Identify potential translocation sites to establish new populations or bolster existing ones.</li> </ul>
Translocation	<ul style="list-style-type: none"> <li>Undertake conservation translocations to establish new populations, re-establish previous populations, or bolster declining populations if required to meet the objectives of the action statement.</li> </ul>

## Past Actions

The key conservation management actions listed below have been delivered in the past 10 years.

Past action	Description
Control introduced fish	<ul style="list-style-type: none"> <li>Introduced trout detection and removal undertaken annually over the past decade.</li> </ul>
Develop, update and apply forestry protections	<ul style="list-style-type: none"> <li>The risk of forestry operations was assessed for the Dargo Galaxias in 2020 under the Victorian Government Threatened Species and Communities Risk Assessment. Additional permanent protections were not found to be required.</li> </ul>
Protect key habitat	<ul style="list-style-type: none"> <li>Parks Victoria has undertaken a range of actions at the head of the catchment, funded under a Peatland Protection program which have delivered benefits for Dargo Galaxias habitat. This includes installing barriers to prevent off-road driving, weed control along streamlines and regular surveillance for incursions of feral horses to confirm the area remains horse-free.</li> </ul>
Research	<ul style="list-style-type: none"> <li>A specific needs assessment was undertaken for the mountain galaxias species complex following the 2019/20 bushfires.</li> <li>A genomic single nucleotide polymorphism analysis of the mountain galaxias species complex in Victoria was published in 2022.</li> <li>An investigation into management options to help ensure the persistence of threatened galaxiids is underway at the Department of Energy, Environment and Climate Action (DEECA).</li> </ul>

Past action	Description
Survey and monitoring	<ul style="list-style-type: none"> <li>• Rapid on-ground assessment undertaken to assess habitat and population status post the 2019-20 bushfires.</li> <li>• Extensive surveys conducted in 2016 identified 10 additional subpopulations in Precipice, Paw, Tabletop, Eighteen Mile, Frazers, Frosty, Jones, Pike, Shepherd, and Twenty-Five Mile creeks.</li> <li>• Translocation monitoring undertaken in 2015 at Little Dargo River.</li> <li>• Detailed population monitoring and collection of demographic information undertaken in 2013-14.</li> <li>• A number of additional locations in the Lightbound Creek catchment were assessed as translocation sites in 2013-14. None were found to be suitable.</li> <li>• Threat monitoring undertaken following the Alpine South Fire in 2012-13.</li> </ul>
Translocation	<ul style="list-style-type: none"> <li>• Translocation of 116 fish from Lightbound Creek to Little Dargo River occurred in 2014 which failed to establish a population however an additional translocation was undertaken in 2022. Further research is required to understand barriers to translocation success.</li> <li>• Translocation of 51 fish from Lightbound Creek to an upper tributary of Homeward Bound Creek occurred in 2015, however a population failed to establish. Further research is required to understand barriers to translocation success.</li> <li>• Following the 2019–20 bushfires, emergency rescue operations captured 200 individuals in February 2020 before returning them to the capture site in September 2020.</li> </ul>
